## BUSINESS PERMIT FOR DOOR-TO-DOOR VENDORS

- Permit required for each individual or organization applying
- Copy of drivers license or state-issued ID required
- Two photographs of each applicant, measuring at least 1.5" x 1.5" and showing the head and shoulders of the applicant in a clear and distinguishing manner, which shall have been taken within the preceding 60 days before filing the application
- Proof of possession and copy of any license or permit which, under federal, state, or local laws or regulations, the applicant is required to have in order to conduct the proposed solicitation or canvassing

If the applicant is an entity that sponsors or employs minors as solicitors and is submitting one application, the information set forth in Ordinance 25-05 Section 3(b).
