## **Supplemental Notice of Emergency Meeting of Blossom City Council Texas Government Code Section 551.045**

Notice is hereby given of an Emergency Meeting of the City Council for the City of Blossom at 5:30pm, February 23, 2023 at 1240 W Front Street, City Hall Building, Blossom, Texas said meeting directly related to an emergency or urgent public necessity related to injury to the Public Works Director, resulting in missed work, which impacts on the water services, including but not limited to public drinking water and sewer services which poses a threat to public health and safety.

Supporting facts: The Public Works Director has sustained injuries, the extent of which are unknown which has resulted in 48 hours absence from work. Because of the limited number of employees in the City, the impact of the absences may be a threat to public health and safety regarding public water and sewer. At the time of posting, the City is not aware of the extent of the injury, or the time required for recovery, treatment healing, only that the Director has missed two (2) days of work.
